



Privacy Notice

The Friends of King Henry's Walk Garden are committed to protecting and respecting your privacy. This notice explains the types of personal data we collect when you interact with us. It also explains how we will store and manage that data and keep it safe.

Personal data collected from you

The Friends of King Henry's Walk Garden collect and process data given to us directly by you in the following ways:

- filling in an application or booking form on our website;
- completing an application or booking form and submitting it by post or email;
- contacting us through any media with enquiries, complaints, or feedback.

It includes data provided when you join King Henry's Walk Garden, subscribe to our mailing lists or book onto one of our activities.

The data may include your name, address, email address and phone number. For membership, bookings or volunteering it might also include information on any special needs you have (potentially 'sensitive personal data').

Use of your personal data

The Friends of King Henry's Walk Garden use the data held about you in the following ways:

- to provide you with information about our activities;
- to contact you about an activity in which you are participating;
- to add you to our mailing lists.

As a member of King Henry's Walk Garden, we will add you to our register of members. We may also use your personal data to inform you about offers of interest from third parties.

We will only keep your personal data for so long as necessary for the purpose for which it was collected. At the end of that retention period the data will be deleted or may be anonymised for use in statistical analysis.

We have security processes and passwords in place to keep the data transmitted to us via the internet or email safe.

We will not disclose your personal data to third parties unless required to do so by law.

Legal bases for processing your personal data

The Friends of King Henry's Walk Garden use the personal data provided for the purpose of membership by you to pursue our legitimate interests in furthering the aims of the charity. Examples include social and fundraising events; talks, walks and workshops; volunteer work sessions and plot holder weekend rota duty.

We will seek your explicit consent to processing:

- personal data you provide when signing up to our mailing lists for marketing purposes;

- any sensitive personal data you provide as part of an application for membership, booking for an activity or volunteering.

Withdrawing your consent

You can withdraw consent to the processing of your sensitive personal data by writing to the address below or emailing info@khwgarden.org.uk.

Personal data given to subscribe to our mailing list on Mailchimp will be held indefinitely but you can withdraw from these mailings at any time by clicking the unsubscribe link in an email.

Third party services

The Friends of King Henry's Walk Garden may employ the services of third parties for dealing with parts of the website. Currently third parties are used to process data entered for mailing list subscriptions. We use Mailchimp for our mailing database and Google as our own email platform. Those companies have procedures in place to ensure privacy of data is safeguarded.

We also use PayPal for membership applications and workshop bookings.

Links to third party websites

We provide links on our website to other websites. We have no control over such websites and this privacy notice does not extend to your use of these.

Rights to control your personal data

You have the right to ask for a copy of your personal data held by the Friends of King Henry's Walk Garden. You also have the right to request that the data be rectified or deleted. In each case, please write to us at the address below or email info@khwgarden.org.uk.

If you feel that your data has not been handled correctly you have the right to lodge a complaint with the Information Commissioner's Office. You can call them on 0303 123 1113 or go online to <https://ico.org.uk/make-a-complaint>.
